### **PYROTECHNIC PERMIT APPLICATION**

The following items shall be attached with the Pyrotechnic Permit Application:

- 1) Completed Falcon Fire Department Pyrotechnic Permit Application
- 2) Copy of lease agreement or written permission from the land owner that approves that use of the land for the purpose of launching pyrotechnics
- 3) Good Neighbor Agreement from all surrounding properties that lie within 2000 feet of the launch site.
- 4) Copy of public liability insurance in the amount of \$1,000,000.00. The Falcon Fire Protection District shall be named as the beneficiary
- 5) Copy of the Operator's License
- 6) Copy of the invoice from the pyrotechnic supplier. This must indicate the number and amount, types and sizes of shells that will be fired
- 7) Copy of the Alcohol Tobacco and Fire Arms (ATF) License
- 8) Copy of Pyrotechnics Guild International Certificate which indicates that at least one on-site operator has successfully the Display Fireworks Shooters Safety Certification Program
- 9) A letter from the pyrotechnic display company providing information on their personnel involved with the display, including their training, qualifications and applicable certifications
- 10) The Pyrotechnic Shot Plan (included in this permit application)
  - a. Scaled Drawing
  - b. Indicate Set Backs
  - c. Property Lines
  - d. All Nearby Structures
  - e. Parking Areas
  - f. Spectator Areas
  - g. Security Fencing
  - h. Fire Suppression Equipment (Including Fire Extinguishers)
  - i. On-site Storage
  - j. Location of Mortars
  - k. No Smoking/Open Flame Signs

9) The Lead Shooter shall meet with a representative form the Falcon Fire Protection District at the display site after the permit application has been submitted, but at least 10business days prior to the scheduled event.
